 - DELAYED ENTRY:** Listing is to be activated in MLS at a later date. Upon entry into MLS, submit this form or the listing agreement. **A Limited Marketing Authorization and Disclosure Form must be completed and signed by the seller, but its upload is not required.**
 - COMING SOON:** Showing Start Date is a maximum 10 calendar days from Contract Date. **Coming Soon Seller Authorization MUST accompany this form. Public Advertising must include "Coming Soon. No Showings until mm/dd/yyyy (the Showing Start Date)."**
 - UNDER CONSTRUCTION:** Must move to Active no later than the issuance of Certificate of Occupancy.
- 2) **AUTHORITY NOT GRANTED:** Check only if the property listed will not be entered in the MLS System for the duration of the listing agreement. **A Limited Marketing Authorization and Disclosure Form must be completed and signed by the seller, but its submission to MLS is not required.**
